In the event of failure to pay for utility services by the due date, I understand that the City may impose late fees, shut off fees, account deposits, and other additional fees for which I am responsible to pay the City. In the event that the above property is vacant or not in use, I understand that I am still responsible for the applicable charges regardless of utility consumption.

I understand that the City shall have the right to shutoff services for non-payment. I also understand the City will take all necessary action to collect delinquent accounts. I agree to pay all additional fees, including but not limited to attorney fees and collection fees. I also agree to be bound by all rules and regulations of the Municipal Code of the City of Washington Terrace.

I understand that it is unlawful for any person to destroy, damage, deface, bypass, modify, render inoperable, or otherwise tamper with any water meter pit or water meter that is in use in the city in any way that changes its calibrated use and operation for metering water or otherwise interfering with water delivery in any manner.

I, as the legal property owner, understand that I am responsible to notify the City of any changes in mailing address, renters, or vacancy of the property. If the service address is used as a rental property, I understand that I must abide by all City rules and ordinances and obtain a business license. I also understand that as the legal owner of the property, I am responsible for all charges on the account.
